TISCO Financial Group Public Company Limited ("the Company") has determined the 2020 Annual General Meeting of Shareholder ("AGM") on Friday, June 26, 2020. Due to the ongoing situation of COVID-19 outbreak, we have set several measures and guidelines related to hosting the meeting to comply with the recommendations from the related authorities for health and safety of all participants which may cause inconveniences and delay. Besides, we intend to keep the meeting short and concise to limit the period of large gathering of people, and to enforce social distancing at least one meter between each other resulting in less number of seating allowed for the meeting room. Therefore, we would like to ask your kind cooperation as follows:

1. Request for Shareholders' kind cooperation to grant a proxy to the Company's Independent Directors to attend the meeting on behalf of Shareholders

To reduce the risks of virus spreading from the crowding of shareholders on the meeting day

- 1.1 Complete the Proxy Form B and send it together with the identification documents for meeting attendance using the reply envelope (no postal stamp required). On June 11, 2020, the proxy form and the reply envelope are sent together with the AGM Notice.
- 1.2 Shareholders who have queries relating to the meeting agenda may send them to the Company by e-mail at tisco_cs@tisco.co.th indicating name, surname and contact information of the sender, or enclose with the submission of your proxy form. We shall record questions and answers in the minutes of the Shareholder Meeting as deemed appropriate.

The Independent Directors who serve as your proxies will perform their duties with transparency and for the utmost benefits of shareholders.

2. Screening and registration processes for shareholders/proxies attending the meeting

Please read measures and guidelines of attending the meeting and cooperate with the screening process or you will be denied from entering the meeting. Kindly note that the concealment of health information or traveling record may

be considered a violation of the Communicable Diseases Act B.E. 2558.



- All Attendees must truthfully fill in a Health Declaration Form (attached) before entering the venue. If you or your close contacts have any of the exposures specified in the Health Declaration Form, you will not be allowed to enter the building or the meeting room. In such case, you can appoint the Company's Independent Director as your proxy and we will take action as deemed appropriate.
- 2.2 <u>Every attendee must pass body temperature check.</u> Attendee whose body temperature is 37.5 degrees Celsius or higher, or has respiratory symptom such as coughing, sore throat, sneezing or runny nose, will be handled according to Step 2.1 above.
- 2.3 The Company organizes social distance of at least one meter to avoid crowded gathering in the building such as at the screening point, document-checking stations and registration counters, and limits the number of passenger in elevator. All attendees must wear face masks at all times while being in the building and the meeting and clean their hands frequently with hand sanitizer provided at many service points.
- 2.4 All attendees must check-in and check-out the building and the meeting room using their mobile phone to scan the QR Code "Thai Chana" at the registration points for check-in and at the exits for check-out. This measure is intended to prevent the risks and spread of COVID-19.
- 2.5 The Company will allow only the registered shareholders / proxies to attend the shareholder meeting and will not allow to accompany other person to the meeting.
- 2.6 <u>No food or beverage are provided.</u> <u>Eating and drinking are strictly prohibited in meeting area</u> to prevent the risks and spread of COVID-19.

3. For attending the meeting

- 3.1 The Company arranges to maintain a 1.5 meters distance between each seating. So the number of available seats in the meeting room are limited at only 50. A specific seat number will be assigned for each of registered attendees. Once all seats are occupied, the attendees will be directed to another seating area outside the meeting room. For the purposes of identifying, controlling, and preventing the risks and spread of COVID-19, the Company requests all attendees to sit only at the seat each of them was assigned (not allow to select or move to other seat during the meeting).
- 3.2 No microphone is provided for the attendees in the meeting room. Questions from the floor must be written down and handed to our staff. Only the questions related to the agenda where the voting is involved will be addressed in the meeting.

The above measures may cause delay in some processes if many attendees happen to arrive at the same time. We have to apologize for any inconvenience this may cause.
